Re: Approval/Withholding of admission for MBA Course 2017-18 in respect of Lead College of Management, Dhoni, Palakkad – Order issued on 13.11.2017.

APPROVAL ORDER

- 1) The Lead College of Management, Dhoni, Palakkad, in short the College, has already submitted the Prospectus and the Fee details of the college for the academic year 2017-18, before the ASC for approval. The same was provisionally approved as per the order no **ASC 100/17/MBA/LCM** dated 19.04.2017.
- 2) The college has now submitted the admission lists with supporting documents to establish the right of claim of admission to MBA course for the academic year 2017-18.

- 3) As per AICTE, the sanctioned intake of the college for the MBA Course is 180 for the academic year 2017-18. The total admitted strength for the current academic year is **132**.
- 4) The college further submitted an email dated 13.11.2017 stating that **five (05)** candidates viz **Aju Vargeese, Abhijith V, Abhijith S Kumar, Shone Cicil** and **Jhon Britto** have been removed from the rolls of the college. Hence the remaining admitted strength for the current academic year is **127**.
- 5) The ASC has scrutinised the entire documents submitted by the college and found that the documents of **116** candidates are found acceptable. Therefore the admissions of the **116** candidates are hereby **approved**.
- 6) **Three (03)** candidates, viz **Aiswarya K, Fabin K** and **Saheerali M K** are not qualified as per the KMAT score card issued by the ASC. The Principal of the college has been informed of the matter and directed to produce the certificate if any to establish the right of claim of admissions of above candidates. Accordingly the college has produced caste certificates in respect of the above candidates, showing that the admitted candidates belong to SEBC category. The above documents were verified and found acceptable. Therefore the candidates are found eligible for admission, as they have scored 95,104 and 90 marks respectively which is above the cut off mark for SEBC category. Therefore the admissions of the above three candidates are hereby **approved**.

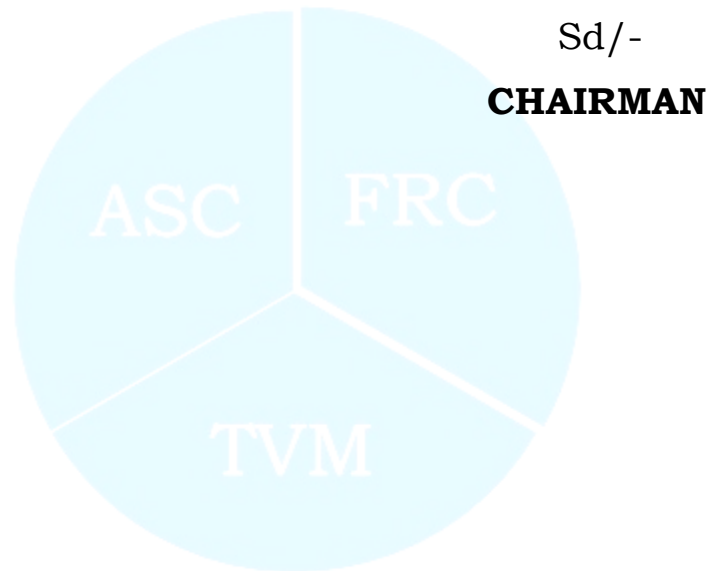

1. The Lead College of Management, Palakkad, herein after referred as MBA College, have submitted the Prospectus before the Admission Supervisory Committee, in short the ASC, for approval and the same has been provisionally approved by the ASC on 27.02.2020.
2. The ASC through communication dated 02.11.2020 has directed the Principals of the MBA College to submit the scanned copies of the list and supporting documents of admitted MBA candidates for the academic year 2020-21 before the ASC for approval.

3. Accordingly, the MBA College through communication dated 08.12.2020 has submitted the list and supporting documents of admitted MBA candidates.
4. The MBA College has submitted the affiliation order received from the competent authorities for conducting the above course. The ASC scrutinised the affiliation order and found that the MBA College is having an intake strength of 180 MBA Seats for the academic year 2020-21.
5. In the present Pandemic Situation, the ASC has relaxed the admission procedure and issued certain directives for admission to MBA Course 2020-21. Wherein the MBA College shall give first preference to those candidates who have qualified in any of the Entrance Test such as KMAT, CMAT & CAT. If any vacancy arises after admitting the qualified candidates, the 2nd preference will be given to the candidates who have secured positive score in any of the above entrance tests. If vacant seats are still remain vacant, the candidates shall be selected based on the qualifying degree examinations.
6. On verifying the records it is found that the MBA College has admitted 196 candidates in MBA Course for the academic year 2020-21. 178 candidates under Management quota and 18 candidates under EWS quota (10% of sanctioned intake of 180 seats i.e. 18). Among the 196 candidates admitted 94 candidates has qualified in Entrance Tests, 31 candidates based on Positive Score in entrance tests and 71 candidates based on Degree Marks.

7. The MBA College further submitted that Mr. Jebin Babu has discontinued from the course. Hence the remaining admitted strength under Management quota for the current academic year is 177.
8. The ASC scrutinised the documents of 177 candidates admitted in the Management quota and found that the documents of 172 candidates are acceptable and they are eligible for admission to MBA Course. Therefore, the admissions of the 172 candidates are hereby approved, as per the list shown in Annexure I.
9. The ASC hereby withhold the admissions of 5 candidates in the Management quota as the MBA College has not submitted relevant documents to establish their right of claim of admission. 4. Letter No L202101208ASC/3705 dated 08.12.2021 from the Director, Lead College of Management, Palakkad.

ORDER

1. The Lead College of Management, Palakkad, herein after referred as MBA College, have submitted the Prospectus before the Admission Supervisory Committee, in short the ASC, for approval and the same has been provisionally approved by the ASC on 17.06.2021.
2. The ASC through communication dated 10.11.2021 has directed the Principals of the MBA College to submit the scanned copies of the list and supporting documents of admitted MBA candidates for the academic year 2021-22 before the ASC for approval.

3. Accordingly, the MBA College through communication dated 08.12.2021 has submitted the list and supporting documents of admitted MBA candidates.
4. The MBA College has submitted the affiliation order received from the competent authorities for conducting the above course. The ASC scrutinised the affiliation order and found that the MBA College is having an intake strength of 300 seats in self financing stream for the academic year 2021-22.
5. In the present Pandemic Situation, the ASC has relaxed the admission procedure and issued certain directives for admission to MBA Course 2021-22, Wherein the MBA College shall give first preference to those candidates who have qualified in any of the Entrance Test such as KMAT, CMAT & CAT. If any vacancy arises after admitting the qualified candidates, the 2nd preference will be given to the candidates who have secured positive score in any of the above entrance tests. If vacant seats still remain vacant, the candidates shall be selected based on the qualifying degree examinations.
6. On verifying the records it is found that the MBA College has admitted 302 candidates in MBA Course for the academic year 2021-22. 294 candidates under management seats and 8 candidates under EWS. Among the 302 candidates admitted 112 candidates has qualified in entrance tests, 2 candidates based on positive score in entrance tests and 188 candidates based on degree marks.

7. The ASC scrutinised the documents of 294 candidates admitted in the management seats and found that the documents of 275 candidates are acceptable and they are eligible for admission to MBA Course. Therefore, the admissions of the 275 candidates are hereby approved, as per the list shown in **Annexure I**.
8. The ASC hereby withhold the admissions of 19 candidates in the management seats as the MBA College has not submitted relevant documents to establish their right of claim of admission. Therefore, the admissions of 19 candidates are withheld subject to the production of documents. The list of withheld candidates and details of documents to be produced are mentioned in the **Annexure II**.
9. The admission of the candidates admitted under EWS during the academic year 2020-21 is under challenge before the Hon'ble High Court of Kerala in WP(C) No.9250 of 2021. The approval of 8 candidates admitted under EWS is kept in abeyance till the disposal of the above writ petition before the Hon'ble High Court and shall be subject to the decision of the above case. 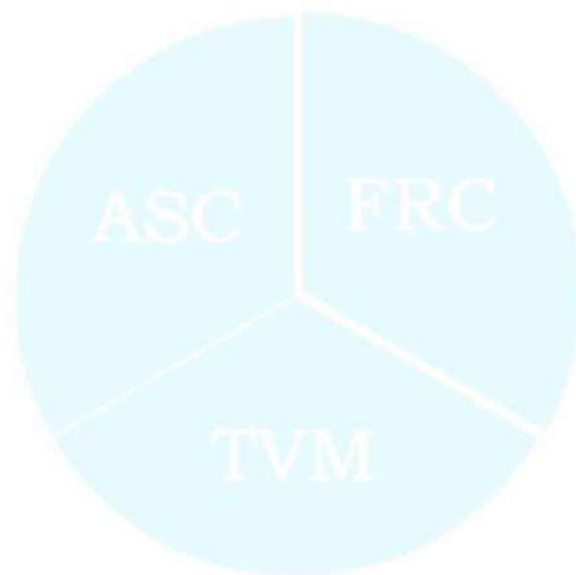

ORDER

1. Lead College of Management, Palakkad, hereinafter referred to as the MBA College, submitted the Prospectus and the same was provisionally approved by the Admission Supervisory Committee, hereinafter referred to as Committee, as per order referred to as first paper above.
2. The Committee, through communication referred to as 3rd above, directed the Principal of the MBA College to produce the list and supporting documents of the admitted candidates in respect of MBA Course for the academic year 2022-23.
3. Accordingly, the MBA College submitted the list and supporting documents of admitted MBA candidates for approval. The MBA College also submitted the

affiliation order received from the competent authorities for conducting the MBA Course for the academic year 2022-23. The Committee scrutinised the documents submitted by the MBA College and found that the College is having an intake strength of 300 seats in self financing stream for the academic year 2022-23.

4. In view of the unfortunate situations that continued consequent on the pandemic, the Committee relaxed the admission procedure and issued certain directives based on the order issued by the Government for admission to MBA Course 2022-23. Accordingly the MBA College was able to give first preference to those candidates who have qualified in any of the Entrance Test such as KMAT, CMAT & CAT. If any vacancy arises after admitting the qualified candidates, the 2nd preference will be given to the candidates who have secured positive score in any of the above entrance tests. If seats still remain vacant, the required number of candidates shall be selected based on the qualifying degree examinations.
5. On verifying the records it is found that the MBA College admitted 290 candidates in MBA Course for the academic year 2022-23. Among the 290 candidates admitted, 146 candidates have qualified in entrance tests and 144 candidates based on degree marks.
6. On scrutiny of the documents, it is found that the documents of the 287 candidates are acceptable and they are eligible for MBA admission. Therefore, the admissions of the 287 candidates are hereby approved, vide list given in Annexure I.
7. The Committee hereby withhold the admissions of three candidates, as the MBA College have not submitted relevant documents to establish their right of claim of admission.
