## **ORDER**

Autonomy for a period of five years from the academic year 2024-2025 to 2028-2029 was granted to LEAD College of Management, Dhoni, Palakkad, in compliance with the UGC decision vide U.O. read as 1<sup>st</sup>.

- 2. An amount of  $\P9,26,160$ /- (Rupees Nine lakh twenty six thousand one hundred sixty only), ( $\P4,63,060$ /- as Administration fee and  $\P92,620$ /-as Affiliation fee (per batch)) fixed vide ref 2, is remitted by the college and applied for one time affiliation for their MBA programme (300 seats) vide paper read as 3  $^{\text{rd}}$ .
- 3. As per the clause 3.5 of UGC (conferment of autonomous status upon colleges and measures for maintenance of standards in autonomous colleges) Regulations 2018, the autonomous colleges need not pay affiliation fee to the parent University every year. One time fee can be paid at the time of conferment of autonomous status. Such fee can be decided by the executive council of the parent University. As per the Amendment of University Laws Act 68 PA (9), the Autonomous College shall pay one time affiliation fee and such other amount to the University at the time of conferment or extension of autonomous status in accordance with the provisions contained in this Chapter.
- 4. Considering the matter in detail, the Vice Chancellor has accorded sanction to place the matter before the Syndicate.
- 5. The meeting of the Syndicate, vide item No.2024.102\* granted One Time Affiliation from the academic year 2024-2025 to 2028-2029 to the MBA programme.
- 6. Sanction has been accorded by the Vice Chancellor to implement the above said resolution of the syndicate.
- 7. Orders are, therefore, issued for granting One Time Affiliation to the MBA programme (300 seats) at LEAD College of Management, Dhoni, Palakkad from the academic year 2024-2025 to 2028-2029 subject to the terms and conditions thereunder.
  - The college shall strictly follow the criteria and guidelines for the extension of the autonomous status, measures for maintanance of standards in autonomous colleges, procedure for introduction of new programmes and regarding the surrendering of autonomous status vide U.O read as 5<sup>th</sup>.
  - Selection and admission shall be in accordance with the rules and regulations of the University/Government and the directions issued by the University/ Government from

time to time.

- In the light of the directions of the Hon'ble Supreme Court of India in WP (C)656/1998,the institution should take appropriate measures for prevention of ragging.
- The Syndicate shall have the power to inspect and verify whether a college that has been granted autonomous status by the University Grants Commission has violated any of the conditions specified for the grant of such autonomous status.
- Violation of any of the above may lead to the cancellation of affiliation.
